# Agreement

1. Dog Kidz Country Daycare & Boarding (Facility) agrees to exercise due diligence and reasonable care and to keep the premises sanitary and properly enclosed. All pets are handled or cared for by the Dog Kidz staff without liability on the facility's part for loss or damage from disease, theft, fire, death, escape, injury, or harm to persons, other pet(s) or property by said pet, or from other unavoidable causes, due diligence and care having been exercised. If, despite our diligence, injuries as indicated should occur, the responsible party's owners would be liable. Owner agrees that Owner has inspected the facilities and finds same in safe and proper order.
2. **Medical:** Should any pet become ill or seem to be in need of medical assistance, the Facility reserves the right to administer aid and/or transport to, and be treated by, any available veterinarian. Any expenses so incurred shall be paid by the Owner of said pet in addition to any other expenses incurred by the Facility for services provided. Facility agrees to notify owner of any medical situation immediately but not to allow that notification to delay any medical treatment. Facility shall assume that owner desires surgical care if recommended by a veterinarian in the event of any life threatening injury or illness unless the Facility is instructed in writing on the Registration Form that dog(s) are not surgical candidates.
3. **Fees:** Owner agrees to pay the rate for services in effect on the date their pet is checked into the Facility. Prices are subject to change at any time, without notice. Owners purchasing plans for multiple visits will not be affected by any rate change until such a time the plan is renewed. Cancellation fees may be applied for "no shows" or reservations cancelled with less than 24 hours notice. Owner shall remain liable for all charges incurred for the care and maintenance for all pets left at the Facility.
4. **Facility Liability:** Facility provides human supervision in person or on camera of dogs at all times and keeps dogs separated by size and age but does not warrant that there will be no accidents, injuries, fights or other normal dog behaviors. Owner hereby consents to Facility using appropriate behavior intervention techniques such as spraying with water, shouting, and other non-violent methods of restoring order if required. It is expressly agreed that the Facility's liability shall in no event exceed the lesser of the current tangible value of a pet of the same species or the sum of \$500.00. The Owner agrees to be solely responsible for any and all acts or behavior of said pet while in the care of the Facility and to hold the Facility harmless from any and all claims arising from damage or injury caused by Owner's dog(s) to any other dog and to defend the Facility from such claims. Owner agrees to disclose any and all hazardous or dangerous propensities of dog(s) placed in the care of the Facility. The Owner agrees to pay reasonable attorney fees incurred by the Facility in the collections of any charges for services incurred by the Owner.
5. **Health:** Owner warrants that Owner is the lawful owner of every pet as listed on the Registration Form. Pet must be in good general health and Owner must provide valid proof of all required vaccinations (Rabies, Distemper, Parvo, and Bordetella) on pet's first visit to the Facility, when vaccinations are updated, and/or annually. Pet must also be on a scheduled prevention program for heartworm, fleas, and ticks. Flea and tick service can be provided by Facility at a fee. Pets arriving at the Facility with fleas and ticks will be bathed and treated by the Facility at the Owner's expense. The Facility reserves the right to refuse services or admittance to any dog.
6. **Hours:** Dogs may be checked in anytime after 7:00 am. Daycare dogs not picked up by closing will be boarded at owner's expense. Pet will only be released to an Owner or pre-approved Owner's agent as listed on the Registration Form. If agent is not listed on form, Owner must provide either written or verbal authorization directly to the Facility granting the agent permission to pick up the pet. Said permission will be considered specific to that day until such a time as Owner revises the Registration Form. Should Owner or pre-approved Owner's agent fail to contact the Facility within 48 hours of expected pick up time, pet will be considered abandoned. Any expenses incurred for the transport, boarding, and/or placement or adoption of said pet shall be the responsibility of the Owner. Owner hereby grants a lien on said pet for any and all unpaid charges resulting from services provided by, at, or through the Facility. Owner agrees to notify Facility of any changes in mailing address, email address, telephone numbers, itineraries or other information reasonably necessary to contact Owner in the event of an emergency.
7. **Dog Park:** As in daycare, all dogs must be approved for the park. Bringing other dogs to the park will result in expulsion from the park and revocation of all paid fees.
8. **Media:** Owner agrees that their pet may be videotaped, photographed, and/or recorded. The Facility shall be the exclusive owner to the results and all proceeds of such tapings, photography, and recordings with the rights throughout the world, an unlimited number of times in perpetuity, to copyright, to use and to license to others in any manner. Owner further agrees that their pet may be used in any and all media and in promotion, advertising, sale, publicizing of the Facility.
9. **Dog ID:** Owner assumes all responsibility for determining that the dog(s) picked up by owner or an authorized agent are, in fact, the correct dog(s). If the wrong dog is taken home, owner shall promptly take steps to remedy the error. Owner releases Facility from any liability for such error.
10. It is agreed by the parties that this Agreement may be changed or terminated upon thirty (30) days notice.
